

**RESOLUTION NO. 466 -2009, AUTHORIZING THE COUNTY EXECUTIVE TO ENTER INTO AN INTERMUNICIPAL AGREEMENT WITH THE TOWN OF BROOKHAVEN IN CONNECTION WITH THE MAINTENANCE OF A PARCEL LOCATED IN SWAN LAKE COUNTY PARK**

**WHEREAS**, the Town of Brookhaven is acquiring a small parcel, Tax Map No. 0200-977.60-02.00-012.000, located immediately adjacent to Swan Lake County Park; and

**WHEREAS**, the Town of Brookhaven is scheduled to demolish and remove a structure located on this parcel; and


**WHEREAS**, both Brookhaven Town and the County of Suffolk wish to enter into an agreement whereby the County shall manage and maintain this small (.145 of an acre) Town-owned parcel; now, therefore be it

**1st RESOLVED**, that, pursuant to Article 5-G of NEW YORK STATE GENERAL MUNICIPAL LAW, the County Executive, or his designee is hereby authorized and empowered to execute an Intermunicipal Agreement with the Town of Brookhaven whereby the County of Suffolk shall manage and maintain the parcel described herein, located immediately adjacent to Swan Lake County Park; and be it further

**2nd RESOLVED**, that the Intermunicipal Agreement and all other contract documents shall be subject to the approval of the County Attorney.
