

RESOLUTION NO. 576 -2009, REQUIRING THE DEPARTMENT OF HEALTH SERVICES TO ESTABLISH THE OBJECTIVE CRITERIA FOR DREDGING PROJECTS PURSUANT TO LOCAL LAW NO. 50-2006

WHEREAS, the Suffolk County Dredging Projects Screening Committee was established to investigate proposed County dredging projects and recommend to this Legislature projects that further the public interest; and

WHEREAS, Local Law No. 50-2006 added ecological health and marine productivity as acceptable criteria for County dredging projects; and

WHEREAS, in order to implement Local Law No. 50-2006, the Department of Health Services hired a consultant to develop objective criteria to determine whether proposed dredging projects would, in fact, improve ecological health and marine productivity and thereby further the public interest; and

WHEREAS, after two years, the Department of Health Services has not yet established the objective criteria for ecological health and marine productivity; and

WHEREAS, the unreasonable delay in establishing objective criteria is preventing at least one important dredging project from moving forward; and


WHEREAS, dredging projects that further the public interest must be performed without undue delay; now, therefore be it

1st RESOLVED, that the Department of Health Services shall, within One Hundred Twenty (120) days of the effective date of this Resolution, establish the objective criteria for dredging projects proposed to further ecological health and marine productivity pursuant to §A8-5(B)(11) of the SUFFOLK COUNTY ADMINISTRATIVE CODE; and be it further

2nd RESOLVED, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.


