**RESOLUTION NO. 536 -2009, AMENDING THE 2009
OPERATING BUDGET AND APPROPRIATING FUNDS IN
CONNECTION WITH BONDING FOR A GENERAL LIABILITY
CASE**

WHEREAS, a General Liability case was tried to verdict and the jury awarded \$2,900,000.00; and

WHEREAS, the verdict was appealed and the Appellate Court modified the verdict to \$1,203,885.00 which is accruing interest at a rate of 9% compounded annually from the date of the liability verdict; and

WHEREAS, the aforementioned verdict is a mandated expense that must be paid by the County; and

WHEREAS, sufficient funds for General Liability verdicts are not available in the 2009 Operating Budget; and

WHEREAS, the County Legislature, by Resolution of even date herewith, has authorized the issuance of \$1,300,000.00 in Suffolk County Serial Bonds to cover the cost of said verdict; now, therefore be it

1st **RESOLVED**, that this verdict in the amount of \$1,203,885.00 be bonded and paid under the authority of the Office of Risk Management, County Department of Civil Service, in conjunction with the County Department of Audit and Control and the County Executive's Budget Office; and be it further

2nd **RESOLVED**, that the proceeds of one million three hundred thousand (\$1,300,000) Dollars in Suffolk County Serial Bonds be and are hereby appropriated as follows:


