**RESOLUTION NO. 664 -2009, ACCEPTING AND APPROPRIATING FEDERAL FUNDING IN THE AMOUNT OF \$79,272 FROM THE UNITED STATES DEPARTMENT OF JUSTICE, DRUG ENFORCEMENT ADMINISTRATION, FOR THE SUFFOLK COUNTY POLICE DEPARTMENT'S PARTICIPATION IN THE DEA LONG ISLAND TASK FORCE WITH 85.14% SUPPORT**

**WHEREAS**, the United States Department of Justice, Drug Enforcement Administration, has made \$79,272 in funding available to Suffolk County for participation of the Suffolk County Police Department in the DEA Long Island Task Force; and

**WHEREAS**, said project is a multi-agency task force designed to combat illegal drug activity through a program of enforcement and investigation; and

**WHEREAS**, the operational period of the Program is from September 30, 2008 through September 29, 2009; and

**WHEREAS**, said reimbursement funds have not been included in the 2009 Suffolk County Operating Budget; now, therefore be it


