

**RESOLUTION NO. 760-2009, AMENDING THE DATE UPON
WHICH THE TASK FORCE ON HATE CRIMES IN SUFFOLK
COUNTY MUST SUBMIT ITS WRITTEN REPORT**

WHEREAS, Resolution No. 31-2009 established a Task Force on Hate Crimes in Suffolk County ("the Task Force") to examine the sources of racial tension in the County, the mechanisms used to report such crimes, and provide recommendations to the County on these issues; and

WHEREAS, the Task Force is required to issue a written report to the members of the County Legislature and the County Executive containing its findings and determinations, along with any recommendations for action; and

WHEREAS, the Task Force's current deadline for the submission of the written report is one hundred eighty (180) days subsequent to the effective date of Resolution No. 31-2009, February 18, 2009; and

WHEREAS, during the course of its investigation, the Task Force has determined it needs more time to complete the inquiry and establish its findings and recommendations; and

WHEREAS, Suffolk County seeks to ensure that the Task Force has sufficient time to provide the County with a comprehensive examination of the issues it has been entrusted to study; now, therefore be it

1st RESOLVED, that the 14th RESOLVED clause of Resolution No. 31-2009 is hereby amended as follows:

14th RESOLVED, that this special Task Force shall submit a written report of its findings and determinations together with its recommendations for action, if any, to each member of the County Legislature and the County Executive no later than [one hundred eighty (180) days] one (1) year subsequent to the effective date of this Resolution for consideration, review, and appropriate action, if necessary, by the entire County Legislature; and be it further


2nd RESOLVED, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
