**RESOLUTION NO. 973 -2009, APPROVING RENTAL CHARGES AND LICENSE FEES RECOMMENDED BY PARKS HOUSING RENTAL BOARD AT ITS AUGUST 17, 2009 MEETING**

**WHEREAS**, Local Law No. 30-2008, "A Local Law to Protect the County's Historic and Culturally Significant Properties," established the Parks Housing Rental Board and outlined procedures for setting rental charges and license fees for facilities under the jurisdiction of the Parks Department; and

**WHEREAS**, Resolution No. 571-2009 approved rental charges and license fees for a partial list of facilities under the jurisdiction of the Parks Department; and

**WHEREAS**, at its meeting on August 17, 2009, the Parks Housing Rental Board made its recommendations for rental charges and license fees for additional facilities to the Parks Commissioner; and

**WHEREAS**, the Parks Commissioner has reviewed these additional recommendations of Parks Housing Rental Board and submits his recommendations as set forth in Exhibit A of this resolution; now, therefore be it


**1<sup>st</sup>** **RESOLVED**, that the rental charges and license fees recommended by the Parks Housing Rental Board and the Parks Commissioner as set forth in Exhibit A of this resolution are hereby adopted; and be it further

**2<sup>nd</sup>** **RESOLVED**, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109 (2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
