RESOLUTION NO. 1157 -2009, ACCEPTING AND APPROPRIATING FEDERAL FUNDING IN THE AMOUNT OF \$16,903 FROM THE UNITED STATES DEPARTMENT OF JUSTICE, FEDERAL BUREAU OF INVESTIGATION, FOR THE SUFFOLK COUNTY POLICE DEPARTMENT'S PARTICIPATION IN THE FBI JOINT TERRORISM TASK FORCE WITH 85.14% SUPPORT

WHEREAS, the United States Department of Justice, Federal Bureau of Investigation, has made \$16,903 in Federal funding available to Suffolk County for participation of the Suffolk County Police Department in the FBI Joint Terrorism Task Force; and

WHEREAS, the operational period of the project is from October 1, 2009 through September 30, 2010; and

WHEREAS, said reimbursement funds have not been included in the 2009 Suffolk County Operating Budget; now, therefore be it

1st RESOLVED, that the County Comptroller and County Treasurer be and they hereby are authorized to accept and appropriate said reimbursement funding as follows:


