

RESOLUTION NO. 1211 -2009, APPROPRIATING FUNDS IN CONNECTION WITH RESTORATION OF DRIVEWAYS, GUTTERS AND CATCH BASINS AT THE SUFFOLK COUNTY VANDERBILT MUSEUM (CP 7433)

WHEREAS, the Executive Director of the Suffolk County Vanderbilt Museum has requested planning funds to restore and repair deteriorated driveways, gutters, catch basins and walkways on the grounds of the Museum; and

WHEREAS, recent inspection of the overpass bridge and roadway resulted in restrictions to vehicular traffic to the mansion, due to serious deficiencies that pose a safety threat to Museum visitors; and

WHEREAS, that this Legislature, by resolution of even date herewith, has authorized the issuance of \$100,000 in Suffolk County Serial Bonds; and

WHEREAS, Resolution No. 471-1994, as revised by Resolution No. 571-1998, Resolution No. 209-2000 and Resolution No. 461-2006 established the use of a priority ranking system, implemented in the Adopted 2008 Capital Budget, as the basis for funding Capital Projects such as this project; now, therefore be it

1st **RESOLVED**, that it is hereby determined that this project, with a priority ranking of fifty-nine (59) is eligible for approval in accordance with the provisions of Resolution No. 471-1994 as revised by Resolution No. 571-1998, Resolution No. 209-2000 and Resolution No. 461-2006; and be it further

2nd **RESOLVED**, that the proceeds of \$100,000 in Suffolk County Serial Bonds be and they hereby are appropriated as follows:

and be it further

3rd **RESOLVED**, that the County Department of Public Works is hereby authorized, empowered and directed to take such action as may be necessary, pursuant to complete restoration of damaged, unstable and unsafe driveways and bridges at the Suffolk County Vanderbilt Museum; and be it further

4th **RESOLVED**, that this Legislature, being the lead agency under the State Environmental Quality Review Act ("SEQRA"), Environmental Conservation Law Article 8, hereby finds and determines that this law constitutes a Type II action, pursuant to Section 617.5 (C) (18), (21) and (27) of Title 6 of New York Code of Rules and Regulations ("NYCRR"), in that the law authorizes information collection, including basic data collection and research, and preliminary planning processes necessary to formulate a proposal for an action, but does not commit the County to commence or approve an action. Since this law is a Type II action, the Legislature has no further responsibilities under SEQRA.
