

**RESOLUTION NO. 94 -2010, AMENDING THE 2010
OPERATING BUDGET AND AUTHORIZING THE PURCHASE
OF FOUR PREVIOUSLY LEASED VEHICLES IN THE SUFFOLK
COUNTY DEPARTMENT OF LABOR**

WHEREAS, the Department of Labor's lease for five (5) low mileage 2007 Chevy Impalas in excellent working condition and two (2) low mileage 2007 Chevy Uplander passenger vans expires in March 2010; and

WHEREAS, purchasing these vehicles is a less expensive option for the County than purchasing new replacement vehicles for the County's fleet; and

WHEREAS, it is the desire of the Legislature to exercise the buyout option to purchase three (3) of the 2007 Chevy Impalas and one (1) 2007 Chevy Uplander passenger van to achieve savings for Suffolk County taxpayers; and

WHEREAS, Section 4-31 (G) of the Suffolk County Charter now allows amendment of the County Operating Budget by County Legislators four times during the fiscal year as long as the amendment reduces, lowers, terminates or cancels appropriations; abolishes positions of employment; terminates contract agencies; terminates or reduces the size of County programs or departments, or makes transfers of appropriations that are offset by reductions in other programs; now, therefore be it

1st **RESOLVED**, that the County Department of Public Works, Division of Purchasing, is hereby authorized, empowered, and directed, pursuant to Section 186-2(B)(5)(a) and (6)(c) of the SUFFOLK COUNTY CODE, to purchase the best three (3) of the five (5) previously leased 2007 Chevy Impalas to replace three (3) high mileage vehicles in the Legislature and one (1) 2007 Chevy Uplander passenger van that has the lowest mileage of the leased vans, as soon as their underlying Labor Department leases expire, subject to an assessment of said vehicles by the Suffolk County Department of Public Works before the vehicles are purchased subject to assignment and County Vehicle Standard Provisions of Section 186-2(B)(5) and (6) of the SUFFOLK COUNTY CODE; and be it further

2nd **RESOLVED**, that the following four high-mileage vehicles assigned to the Legislature will be turned over to the Department of Public Works upon receipt of the four previously leased Labor Department vehicles;

3rd **RESOLVED**, that it is the desire of the Legislature to purchase the best three (3) of the five (5) 2007 Chevy Impalas and the one (1) 2007 Chevy Uplander passenger van identified in the chart that follows, as determined by the Department of Public Works, at a total cost not to exceed \$29,500 for the four (4) vehicles;
