

**RESOLUTION NO. 640 -2010, AMENDING THE 2010 OPERATING BUDGET AND TRANSFERRING FUNDS TO THE KNIGHTS OF COLUMBUS OUR LADY OF ROSARY COUNCIL NO. 4428**

**WHEREAS**, the 2010 Operating Budget does not include sufficient funds for Knights of Columbus Our Lady of Rosary Council No. 4428; and

**WHEREAS**, Knights of Columbus Our Lady of Rosary Council No. 4428 is a not-for-profit agency that provides Suffolk County residents with a valuable service; and

**WHEREAS**, it is the desire of the Suffolk County Legislature to amend the 2010 Operating Budget and transfer \$5,000 to the contracted agency Knights of Columbus Our Lady of Rosary Council No. 4428; and

**WHEREAS**, Section 4-31 (G) of the Suffolk County Charter now allows amendment of the County Operating Budget by County Legislators four times during the fiscal year as long as the amendment reduces, lowers, terminates or cancels appropriations; abolishes positions of employment; terminates contract agencies; terminates or reduces the size of County programs or departments, or makes transfers of appropriations that are offset by reductions in other programs; now, therefore be it

**1<sup>st</sup> RESOLVED**, that the 2010 County Operating Budget is hereby amended as follows and that the County Comptroller and the County Treasurer be and hereby are authorized to transfer the following funds and authorizations.




