WHEREAS, funds have been appropriated under Resolution No. 579-2009 within Capital Program Number 1616 Fuel Management/Preventive Maintenance and Parts Inventory Control System to cover the cost of said vehicle under 016-CP-1616.511; now, therefore be it


1st **RESOLVED**, that an increase in the Fleet is hereby authorized for fuel maintenance activities; and be it further
