

**RESOLUTION NO. 749 -2010, AMENDING THE 2010
ADOPTED OPERATING BUDGET TO ACCEPT AND
APPROPRIATE 100% FEDERAL GRANT FUNDS PASSED
THROUGH THE NEW YORK STATE DEPARTMENT OF
HEALTH TO THE SUFFOLK COUNTY DEPARTMENT OF
HEALTH SERVICES FOR THE IMMUNIZATION ACTION PLAN**

WHEREAS, the New York State Department of Health Services has awarded 100% Federal grant funds to the Department of Health Services for the Immunization Action Plan in the amount of \$300,000 for the period 04/01/10-03/31/11; and

WHEREAS, the purpose of this grant funding is to ensure that 90% of all children in Suffolk County are completely immunized by their second birthday; and

WHEREAS, a portion of these funds in the amount of \$282,795 are already included in the 2010 Suffolk County Adopted Operating Budget and \$17,205 needs to be appropriated; and

WHEREAS, these funds are 100% Federally funded; now, therefore be it

1st RESOLVED, that the County Comptroller and the County Treasurer be and hereby are authorized to accept and appropriate \$17,205 in grant funds as follows:


