

**RESOLUTION NO. 814 -2010, ACCEPTING AND APPROPRIATING FEDERAL FUNDING IN THE AMOUNT OF \$16,903.25 FROM THE UNITED STATES DEPARTMENT OF JUSTICE, FEDERAL BUREAU OF INVESTIGATION, FOR THE SUFFOLK COUNTY POLICE DEPARTMENT'S PARTICIPATION IN THE LONG ISLAND CYBER CRIME TASK FORCE (LICCTF) WITH 83.37% SUPPORT**

**WHEREAS**, the United States Department of Justice, Federal Bureau of Investigation, has made \$16,903.25 in Federal funding available to Suffolk County for participation of the Suffolk County Police Department in the LICCTF; and

**WHEREAS**, said project is a multi-agency task force designed to assist the Federal Bureau of Investigation in the detection, investigation, and prosecution of crimes against the United States; and

**WHEREAS**, the operational period of the Program is from October 1, 2009 through September 30, 2010; and

**WHEREAS**, said reimbursement funds have not been included in the 2010 Suffolk County Operating Budget; now, therefore be it


