

RESOLUTION NO. 815-2010, TO EXTEND THE DATE UPON WHICH THE TASK FORCE ON HATE CRIMES IN SUFFOLK COUNTY SUBMITS ITS WRITTEN REPORT

WHEREAS, Resolution No. 31-2009 created a Task Force on Hate Crimes in Suffolk County ("Task Force") to examine the sources of racial tension in the County, the mechanisms used to report such crimes and provide recommendations to the County on these issues; and

WHEREAS, the Task Force is required to issue a written report to the members of the County Legislature and the County Executive containing its findings and determinations along with any recommendations for action; and

WHEREAS, Resolution No. 31-2009, as amended by Resolution No. 760-2009, requires the Task Force to submit its written report by February 18, 2010; and

WHEREAS, the Task Force has determined that it needs more time to complete its analysis and written report; now, therefore be it

1st RESOLVED, that the 14th RESOLVED clause of Resolution No. 31-2009 is hereby amended to read as follows:


14th RESOLVED, that this special Task Force shall submit a written report of its findings and determinations together with its recommendations for action, if any, to each member of the County Legislature and the County Executive no later than [August 31, 2010] December 31, 2010 for consideration, review, and appropriate action, if necessary, by the entire County Legislature; and be it further

2nd RESOLVED, that all other terms and conditions of Resolution No. 31-2009, as amended, shall remain in full force and effect; and be it further

3rd RESOLVED, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
