**RESOLUTION NO. 862 -2010, AMENDING THE 2010
OPERATING BUDGET AND APPROPRIATING FUNDS IN
CONNECTION WITH BONDING A SETTLEMENT FOR A BUS
LIABILITY CASE**

WHEREAS, a settlement was approved in a Bus Liability case by the Ways and Means Committee for a total amount of Three Hundred Fifty Thousand Dollars (\$350,000); and

WHEREAS, the settlement is a mandated expense that must be paid by the County; and

WHEREAS, sufficient funds to satisfy Bus Liability orders, judgments and settlements are not available in the 2010 Operating Budget; and

WHEREAS, the County Legislature, by Resolution of even date herewith, has authorized the issuance of Three Hundred Fifty Thousand Dollars (\$350,000) in Suffolk County Serial Bonds to cover the cost of the above referenced settlement; now, therefore be it

1ST RESOLVED, that this settlement in the amount of Three Hundred Fifty Thousand Dollars (\$350,000) be bonded and paid under the authority of the Office of Risk Management, County Department of Civil Service, in conjunction with the County Department of Audit and Control and the County Executive’s Budget Office; and be it further

2ND RESOLVED, that the proceeds of Three Hundred Fifty Thousand Dollars (\$350,000) in Suffolk County Serial Bonds be and are hereby appropriated as follows:


