

**RESOLUTION NO. 1186 -2010, AMENDING THE 2010  
CAPITAL BUDGET AND PROGRAM AND APPROPRIATING  
FUNDS IN CONNECTION WITH OFF-STREET PARKING OFF  
CR 80 IN PATCHOGUE (CP 5534)**

**WHEREAS**, the reconstruction of CR 80, Montauk Highway, in Patchogue resulted in the need for additional off-street public parking spaces; and

**WHEREAS**, the lack of parking has impacted both the business community and residents alike; and

**WHEREAS**, the construction of off-street, public parking spaces off CR 80 on Bay Avenue in Patchogue will assist residents, visitors and businesses; and

**WHEREAS**, the Town of Brookhaven is committed to assist in the land acquisition process for these improvements; and

**WHEREAS**, this Legislature, by resolution of even date herewith, has authorized the issuance of \$300,000 in Suffolk County Serial Bonds; and

**WHEREAS**, Resolution No. 471-1994, as revised by Resolution No. 571-1998, Resolution No. 209-2000 and Resolution No. 461-2006 established the use of a priority ranking system, implemented in the Adopted 2010 Capital Budget, as the basis for funding capital projects such as this project; now, therefore be it

**1<sup>st</sup>** **RESOLVED**, pursuant to the State Environmental Review Act Environmental Conservation Law Article (hereinafter "SEQRA"), Resolution No. 666 of 2002 classified the action contemplated by this as an Unlisted Action, therefore, the provisions of SEQRA have been complied with and no further action of the Legislature is necessary; and be it further

**2<sup>nd</sup>** **RESOLVED**, that it is hereby determined that this project, with a priority ranking of forty-five (45) is eligible for approval in accordance with the provisions of Resolution No. 471-1994 as revised by Resolution No. 571-1998, Resolution No. 209-2000 and Resolution No. 461-2006; and be it further
