**RESOLUTION NO. 1179 -2010, AUTHORIZING THE SALE, PURSUANT TO LOCAL LAW NO. 16-1976, OF REAL PROPERTY ACQUIRED UNDER SECTION 46 OF THE SUFFOLK COUNTY TAX ACT ROSE LACASCIA, AS SURVIVING TENANT BY ENTIRETY (SCTM NOS. 0100-020.00-03.00-002.000 and 0100-020.00-03.00-003.000)**

**WHEREAS**, the COUNTY OF SUFFOLK acquired the following described parcel:

**ALL**, that certain plot, piece or parcel of land, with any buildings and improvements thereon erected, situate, lying and being in the Town of Babylon, County of Suffolk, and State of New York, described on the Tax Map of the Suffolk County Real Property Tax Service Agency as District 0100, Section 020.00, Block 03.00, Lot 002.000, and acquired by tax deed on September 23, 2009, from Angie M. Carpenter, the County Treasurer of Suffolk County, New York, and recorded on September 28, 2009, in Liber 12601, at Page 256, and otherwise known and designated by the Town of Babylon;

Parcel I – 0100-020.00-03.00-002.000

Lots p/o 11 and p/o 12 in Block 11 on a certain map entitled “Map of Deer Park Terrace, Section 6”, filed in the Office of the Suffolk County Clerk on June 20, 1927 as Map No. 653;

Parcel II – 0100-020.00-03.00-003.000

Lots p/o 13 and p/o 14 in Block 11 on a certain map entitled “Map of Deer Park Terrace, Section 6”, filed in the Office of the Suffolk County Clerk on June 20, 1927 as Map No. 653; and

**FURTHER**, notwithstanding the above description, it is the intention of this conveyance to give title only to such property as was acquired by the County of Suffolk by Tax Deed on September 23, 2009, from Angie M. Carpenter, the County Treasurer of Suffolk County, New York, and recorded on September 28, 2009 in Liber 12601 at Page 256.

**WHEREAS**, in accordance with Suffolk County Local Law No. 16-1976, provision has been made for the sale of such real property acquired by the County through tax sale; and

**WHEREAS**, ROSE LACASCIA, AS SURVIVING TENANT BY ENTIRETY has made application of said above described parcel and ROSE LACASCIA, AS SURVIVING TENANT BY ENTIRETY has paid the application fee and has paid \$585.76, as payment of taxes, penalties, interest, recording fees, and any other charges due the County of Suffolk, pursuant to Local Law, by applicant, through November 30, 2010; now, therefore be it


**1<sup>st</sup>** **RESOLVED**, this Legislature, being the State Environmental Quality Review Act (SEQRA) Lead Agency, hereby finds and determines that adoption of this law is not an action within the meaning of the State Environmental Quality Review Act and the regulations adopted thereto. See 6 N.Y.C.R.R. Section 617.2(b) (2). The Legislature further finds and determines that even if the adoption of the local law is an action within the meaning of SEQRA, the adoption of law is a Type II action constituting a legislative decision in connection with routine or continuing agency administration and management, not including new programs or major reordering of priority. See 6 N.Y.C.R.R. Section 617.13(d) (15) and (21). As a Type II action, the Legislature has no further responsibilities under SEQRA 6 N.Y.C.R.R. Section 617.5(a)(1);
