RESOLUTION NO. 1176 -2010, ACCEPTING AND APPROPRIATING 100% FEDERAL FUNDS AWARDED BY THE FBI TO THE SUFFOLK COUNTY DEPARTMENT OF PROBATION AND AUTHORIZING THE COUNTY EXECUTIVE TO EXECUTE RELATED AGREEMENTS

WHEREAS, the Federal Bureau Of Investigation will provide funding to the Suffolk County Probation Department for the Department's participation in the Long Island Gang Task Force operations; and

WHEREAS, a total of \$17,202.25 has been awarded by the Federal Bureau of Investigation for overtime expenses for services rendered by the Department of Probation for the period of October 1, 2010 through September 30, 2011; and

WHEREAS, said funds have not been included in the 2010 Suffolk County Operating Budget; now, therefore be it

1st RESOLVED, that the County Executive is authorized to execute any Agreement with the Federal Bureau of Investigation, as necessary, to secure said funds; and be it further

2nd RESOLVED, that the non-reimbursable fringe benefits associated with the overtime salaries for this grant are included in the 2010 Suffolk County Operating Budget; and be it further

3rd RESOLVED, that the County Comptroller and the County Treasurer be and they hereby are authorized to accept and appropriate said unbudgeted funds in the amount of \$17,202.25 as follows:


