

**RESOLUTION NO. 102 -2011, APPROVING THE

WHEREAS, Section 6-3(A) and (B) of the SUFFOLK COUNTY ADMINISTRATIVE CODE was amended by Local Law Nos. 26-1999 and 24-2005, extending anti-nepotism provisions to cover relatives of the Police Department Officials when the position is not being filled pursuant to a Civil Service Law competitive examination; and

WHEREAS, the Suffolk County Police Commissioner intends to appoint Kenneth Blomberg, brother of Suffolk County Police Captain Thomas Blomberg, to a position of Detective Sergeant; and

WHEREAS, said employee is presently employed by the Suffolk County Police Department as a Sergeant; and


WHEREAS, said employee is well qualified to fill the position of Detective Sergeant; and
