RESOLUTION NO. 733 -2011, ACCEPTING AND APPROPRIATING 100% REIMBUSABLE FEDERAL ARRA GRANT FUNDS FROM THE NEW YORK OFFICE FOR AGING FOR A CHRONIC DISEASE SELF-MANGEMENT PROGRAM

WHEREAS, the New York State Office for Aging has made available to Suffolk County Office for Aging funding for a local Chronic Disease Self-Management Program in the amount of \$24,750; and

WHEREAS, this grant will be utilized to continue a regional collaboration that will reach seniors with the CDSMP workshops in Suffolk and Nassau Counties; and

WHEREAS, Suffolk County Office for the Aging will contract The Friends of the Retired and Senior Volunteer Program of Suffolk, Inc. which has the necessary qualifications to coordinate and implement this program; and

WHEREAS, the program year will run from April 1, 2011 through March 31, 2012; and

WHEREAS, the 100% Federal grant funds are not included in the 2011 Adopted Suffolk County Budget; and

WHEREAS, it is in the best interest of the County to accept these funds; now, therefore be it


