RESOLUTION NO. 919 -2011, APPROPRIATING FURNITURE AND EQUIPMENT FUNDS FOR THE NEW REPLACEMENT CORRECTIONAL FACILITY AT YAPHANK (CP 3008)

WHEREAS, the Sheriff has requested funds for the Purchase of Furniture and Equipment for the New Replacement Correctional Facility in Yaphank; and

WHEREAS, Suffolk County has committed to the construction of a New Replacement Correctional Facility at Yaphank to address building issues and the continued growth in the number of inmates at the facility; and

WHEREAS, sufficient funds are now included in the 2011 Capital Budget and Program to cover the cost of said request; and

WHEREAS, Resolution No. 471-1994 as revised by Resolution No. 461-2006 established the use of a priority ranking system, implemented in the Adopted 2011 Capital Budget and Program, as the basis for funding capital projects such as this project; and

WHEREAS, the County Legislature, by resolution of even date herewith, has authorized the issuance of \$4,595,339 in Suffolk County Serial Bonds; now, therefore be it

1st RESOLVED, that this Legislature, being the lead agency under the State Environmental Quality Review Act ("SEQRA"), Environmental Conservation Law Article 8, hereby finds and determines that this constitutes a Type II action, pursuant to Volume 6 of the New York Code of Rules and Regulations ("NYCRR") Section 617.5 (25) and (27), in that the resolution concerns purchasing of furnishings, equipment and supplies, other than land, radioactive material, pesticides, herbicides or other hazardous materials, and adoption of a local legislative decision in connection with the same; and be it further

2nd RESOLVED, that it is hereby determined that this project, with a priority ranking of fifty-eight (58), is eligible for approval in accordance with the provisions of Resolution No. 471-1994 as revised by Resolution No. 461-2006; and be it further


3rd RESOLVED, that the proceeds of \$4,595,339 in Suffolk County Serial Bonds be and they are hereby appropriated as follows:
