**RESOLUTION NO. 1067 -2011, DIRECTING THE DEPARTMENT OF PUBLIC WORKS TO INSTALL A FULL THREE-COLOR STOPLIGHT AT THE INTERSECTION OF CR 111 AND HALSEY MANOR ROAD**

**WHEREAS**, pursuant to Resolution No. 1028-2007, a blinking traffic signal was placed at the intersection of CR 111 and Halsey Manor Road; and

**WHEREAS**, since the installation of the traffic signal, several accidents have occurred in the vicinity of this intersection; and

**WHEREAS**, due to development, traffic volumes have increased in recent years on both CR 111 and Halsey Manor Road; and

**WHEREAS**, to ensure the safety of these roads, the traffic signal should be reprogrammed as a full three-color stoplight; now, therefore be it

**1st RESOLVED**, the Department of Public Works is hereby authorized, empowered and directed to reprogram the existing traffic signal at CR 111 and Halsey Manor Road as a full three-color stoplight; and be it further

**2nd RESOLVED**, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
