

**RESOLUTION NO. 1146 -2011, APPROPRIATING FUNDS IN CONNECTION WITH IMPROVEMENTS TO NEWLY ACQUIRED PARKLAND (CP 7145)**

**WHEREAS**, the Commissioner of Parks, Recreation and Conservation has requested construction funds for improvements to newly acquired parkland; and

**WHEREAS**, there are sufficient funds within the 2011 Capital Budget and Program to cover the cost of construction for improvements to newly acquired parkland under Capital Project 7145; and

**WHEREAS**, Resolution No. 471-1994 as revised by Resolution No. 461-2006, established the use of a priority ranking system, implemented in the Adopted 2011 Capital Budget as the basis for funding capital projects such as this project; and

**WHEREAS**, the County Legislature, by resolution of even date herewith, has authorized the issuance of \$50,000 in Suffolk County Serial Bonds; now, therefore be it

**1<sup>st</sup>** **RESOLVED**, that this Legislature, being the lead agency under the State Environmental Quality Review Act ("SEQRA"), Environmental Conservation Law Article 8, hereby finds and determines that this law constitutes a Type II action pursuant to the provisions of Title 6 NYCRR Part 617.5 (c) (25) because it involves the purchase of supplies including fencing, gates and other materials used to secure newly acquired properties and correct environmental hazards; as a Type II action, the Legislature has no further responsibilities under SEQRA; and be it further

**2<sup>nd</sup>** **RESOLVED**, that it is hereby determined that this project, with a priority ranking of thirty-eight (38), is eligible for approval in accordance with the provisions of Resolution No. 471-1994 as revised by Resolution No. 461-2006; and be it further

**3<sup>rd</sup>** **RESOLVED**, that the proceeds of the \$50,000 in Suffolk County Serial Bonds be and they are hereby appropriated as follows:


