

RESOLUTION NO. 133 -2012, APPROPRIATING FUNDS IN CONNECTION WITH IMPROVEMENTS TO RED HOUSE AT INLET POND COUNTY PARK (CP 7122)

WHEREAS, the Adopted 2012 Capital Budget included funding for improvements to Red House at Inlet Pond County Park; and

WHEREAS, the improvements include new siding, a new handicapped entrance and two bathrooms; and

WHEREAS, this Legislature, by resolution of even date herewith, has authorized the issuance of \$120,000 in Suffolk County Serial Bonds; and

WHEREAS, Resolution No. 471-1994, as revised by Resolution No. 571-1998, Resolution No. 209-2000 and Resolution No. 461-2006 established the use of a priority ranking system, implemented in the Adopted 2012 Capital Budget, as the basis for funding capital projects such as this project; now, therefore be it

1st **RESOLVED**, that it is hereby determined that this project, with a priority ranking of thirty-eight (38) is eligible for approval in accordance with the provisions of Resolution No. 471-1994 as revised by Resolution No. 571-1998, Resolution No. 209-2000 and Resolution No. 461-2006; and be it further

2nd **RESOLVED**, that the proceeds of \$120,000 in Suffolk County Serial Bonds be and they hereby are appropriated as follows:



As a Type II action, the Legislature has no further responsibilities under SEQRA.
