

RESOLUTION NO. 43 -2012, AUTHORIZING TECHNICAL CORRECTION TO RESOLUTION NO. 864-2011, INSTITUTING A LAG PAYROLL IN FISCAL YEAR 2012 FOR ELECTED OFFICIALS

WHEREAS, Resolution No. 864-2011 authorized a lag payroll for elected officials in 2012; and

WHEREAS, the Department of Audit and Control has requested technical changes to Resolution No. 864-2011 to ease the administration of the lag payroll; now, therefore be it

1st RESOLVED, that the 2nd RESOLVED clause of Resolution No. 864-2011 is hereby amended as follows:

2nd RESOLVED, that the voluntary participation by elected officials in a "lag payroll" be implemented by deferring the equivalent of ten days of pay over [26] 20 consecutive pay periods beginning with the [first full payroll week] second payroll in January, 2012; and be it further

2nd RESOLVED, that all other provisions of Resolution No. 864-2011 shall remain in full force and effect; and be it further

3rd RESOLVED, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
