

**RESOLUTION NO. 376 -2012, APPOINTING PETER FOX COHALAN TO THE POSITION OF COUNTY HISTORIAN FOR THE COUNTY OF SUFFOLK**

**WHEREAS**, NEW YORK ARTS AND CULTURAL AFFAIRS LAW authorizes the County Legislature to appoint a County Historian; and

**WHEREAS**, a County Historian is responsible to research historic events within the County and promote the preservation of historic documents and materials to ensure a full understanding and appreciation of the County's history; and

**WHEREAS**, Peter Fox Cohalan is a retired Justice of the Supreme Court of the State of New York, who also served as Suffolk County Executive and Islip Town Supervisor; and

**WHEREAS**, Mr. Cohalan has served as a member of the W.K. Vanderbilt Historical Society of Dowling College, the Sayville Historical Society and the American Irish Historical Society; and

**WHEREAS**, Peter Fox Cohalan is eminently qualified to serve as Suffolk's Historian; now, therefore be it

**1st RESOLVED**, that Peter Fox Cohalan, residing in Sayville, New York, is hereby appointed to the position of Suffolk County Historian, pursuant to § 57.07 of NEW YORK ARTS AND CULTURAL AFFAIRS LAW, to serve at the pleasure of the County Legislature; and be it further

**2nd RESOLVED**, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
