

RESOLUTION NO. 149 -2012, REQUIRING THE COUNTY TO CONSIDER THE PLANNING COMMISSION'S GREEN METHODOLOGIES GUIDELINES IN RELATION TO COUNTY PARKING LOTS AND NEW YORK STATE ENVIRONMENTAL FACILITIES CORPORATION'S GRANT PARAMETERS

WHEREAS, the County of Suffolk is a national leader in environmental protection initiatives; and

WHEREAS, stormwater remediation is especially important, as the County is situated on a sole-source aquifer which provides drinking water for residents; and

WHEREAS, the Suffolk County Planning Commission drafted a report entitled "Managing Stormwater – Natural Vegetation and Green Methodologies" to provide municipalities with environmentally sensitive techniques and guidelines for managing stormwater runoff; and

WHEREAS, this report contains suggestions for municipalities to consider when designing and paving parking lots to improve stormwater management; and

WHEREAS, there is grant funding available through the New York State Environmental Facilities Corporation's (EFC) Green Innovation Grant Program, which may be available for designing and paving parking lots to improve stormwater management; and


WHEREAS, to protect the areas surrounding County properties, the County should consider the methods and guidelines suggested by the Planning Commission's report regarding stormwater runoff when designing and/or paving new and existing County-owned parking lots; now, therefore be it

1st RESOLVED, that the Department of Public Works shall consider the techniques and guidelines established in the Suffolk County Planning Commission report "Managing Stormwater – Natural Vegetation and Green Methodologies" and the EFC's Green Innovation Grant Program when preparing to design and/or pave any new parking lot or redesign and/or repave any existing parking lot owned by the County of Suffolk; and be it further

2nd RESOLVED, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
