1st **RESOLVED**, that John Sipala, currently residing at Quogue, New York, 11959, be and he hereby is appointed to the Suffolk County Vocational, Education, and Extension Board to replace Clifford H. Foster, for a term of office to expire on July 31, 2020, said appointment having been made pursuant to the provisions of Section 1101(2) of the NEW YORK EDUCATION LAW.
