

RESOLUTION NO. 74 -2012, ACCEPTING AND APPROPRIATING A GRANT IN THE AMOUNT OF \$912,000 FROM THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION FOR THE LONG ISLAND EXPRESSWAY HIGH OCCUPANCY VEHICLE LANE ENFORCEMENT PROGRAM IN SUFFOLK COUNTY WITH 100% SUPPORT

WHEREAS, the New York State Department of Transportation (DOT) has made \$912,000 available to the Suffolk County Sheriff's Office for the continued Suffolk County enforcement efforts targeting the High Occupancy Vehicle (HOV) lane regulations on the Long Island Expressway in Suffolk County; and

WHEREAS, the operational period of the program is from January 3, 2012, through January 3, 2013; and

WHEREAS, funds have not been included in the Suffolk County Operating Budget for FY 2012; now, therefore be it


