

**RESOLUTION NO. 568 -2012, AUTHORIZING USE OF
SOUTHAVEN COUNTY PARK PROPERTY FOR THE YAPHANK
DAY CAMP TRAIL RUN**

WHEREAS, Yaphank Presbyterian Church would like to use Southaven County Park for the purpose of hosting a 5k trail run to benefit the Yaphank Day Camp, a low-cost summer camp for low income families; and

WHEREAS, the Yaphank Day Camp Trail Run will be held on Saturday, July 14, 2012 between the hours of 3:00 p.m. and 9:00 p.m.; and

WHEREAS, the County of Suffolk shall receive consideration in the total amount of One Hundred Fifty and 00/100 Dollars (\$150.00), payment of which shall be guaranteed by the Yaphank Presbyterian Church; and

WHEREAS, a Certificate of Insurance and the accompanying declaration page naming Suffolk County as an additional insured has been provided by the Yaphank Presbyterian Church; now, therefore be it

1st RESOLVED, that the use of County-owned property, i.e., the Southaven County Park in consideration of the payment of One Hundred Fifty and 00/100 Dollars (\$150.00) for the purpose of holding the Yaphank Day Camp Trail Run on Saturday, July 14, 2012, between the hours of 3:00 p.m. and 9:00 p.m., is hereby approved pursuant to Section 215(1) of the NEW YORK COUNTY LAW, subject to the receipt of a Certificate of Insurance and the accompanying declaration page naming Suffolk County as an additional insured by the County of Suffolk from the Department, and subject to such additional terms and conditions as may be required by the Risk Management and Benefits Division in the County Department of Human Resources, Personnel, and Civil Service; and be it further

2nd RESOLVED, that the Commissioner of the County Department of Parks, Recreation and Conservation is hereby authorized, empowered and directed, pursuant to Section 28-4(A) of the SUFFOLK COUNTY CHARTER and Section 643-7 of the SUFFOLK COUNTY CODE to issue a permit to the Yaphank Presbyterian Church. The County Department of Parks, Recreation and Conservation and the County Department of Public Works are further authorized, empowered and directed, under Section 8-2(W) of the SUFFOLK COUNTY CHARTER, to take such measures, either alone or in conjunction with each other, as shall be necessary and appropriate to facilitate the hosting of the Yaphank Day Camp Trail Run hosted by the Yaphank Presbyterian Church; and be it further


3rd RESOLVED, that the Yaphank Day Camp Trail Run shall also provide an entertainment promoter certificate to Suffolk County if it wishes to allow vendors at the event to sell tangible personal property other than food or drink and require these vendors to display such certificate in order to comply with the provisions of the NEW YORK TAX LAW; and be it further

4th RESOLVED, that this Legislature, being the lead agency under the State Environmental Quality Review Act ("SEQRA"), New York Environmental Conservation Law, Article 8, hereby finds and determines that this resolution constitutes a Type II action, pursuant

to Volume 6 of New York Code of Rules and Regulations ("NYCRR") §617.5(c)(15), (20), and (27), in that the resolution concerns minor temporary uses of land having negligible or no permanent impact on the environment, routine, or continuing agency administration and management, not including new programs or major reordering of priorities, and adoption of a local legislative decision in connection with the same, and since this is a Type II action, the County Legislature has no further responsibilities under SEQRA.
