RESOLUTION NO. 643 -2012, DIRECTING THE DEPARTMENT OF PUBLIC WORKS TO IMPLEMENT BUS FARE REDUCTION FOR VETERANS

WHEREAS, the County of Suffolk provides discounted bus fares to students, seniors and disabled persons; and

WHEREAS, Suffolk County should establish a one (1) year pilot project to provide a discounted bus fare for veterans in recognition of their service to our nation; and

WHEREAS, Transportation Operations in the Department of Public Works indicates that such a fare reduction will not have a negative fiscal impact on the County; now, therefore be it

1st **RESOLVED**, that the Director of Transportation Operations in the Department of Public Works is hereby directed, on a one (1) year pilot basis, to reduce bus fares for veterans on all routes to \$.75; and be it further

2nd **RESOLVED**, that holders of a Suffolk County Veteran Resident Identification Card will be entitled to the veterans discount; and be it further


3rd **RESOLVED**, that the fare reduction for veterans will take effect forty-five (45) days after the effective date of this resolution; and be it further

4th **RESOLVED**, that Transportation Operations will submit a report to the County Legislature at the end of the pilot period describing its impact on ridership and revenues to the County; and be it further

5th **RESOLVED**, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
