**RESOLUTION NO. 681 -2012, ACCEPTING AND APPROPRIATING A SUBCONTRACT FROM THE RESEARCH FOUNDATION OF THE STATE UNIVERSITY OF NEW YORK FOR A PROJECT ENTITLED "SUNY WORKS - ADULT DEGREE COMPLETION" 100% REIMBURSED BY STATE FUNDS AT SUFFOLK COUNTY COMMUNITY COLLEGE**

**WHEREAS**, the Research Foundation of the State University of New York is in receipt of a grant award to carry out a project entitled "SUNY Works - Adult Degree Completion"; and

**WHEREAS**, Suffolk County Community College has been selected to receive \$10,000 of said grant award for the period of April 1, 2012 through October 31, 2012; and

**WHEREAS**, the project provides funding to support the development and implementation of the SUNY Works Cooperative Education Initiative on all three of the College's campus locations; and

**WHEREAS**, the Board of Trustees of Suffolk County Community College accepted the subcontract on June 21, 2012 by Resolution No. 2012.57; and

**WHEREAS**, the College anticipates spending the \$10,000, in accordance with the terms of said grant award before October 31, 2012; now, therefore be it


