WHEREAS, a vacancy has arisen on the District Court bench in the Third Judicial District; and



1st **RESOLVED**, that this Legislature, including those members whose districts or portions thereof are within the area comprising the County District Court System, hereby confirms the appointment of Karen Kerr of the Town of Huntington, New York as District Court Judge for and of the Third Judicial District of the Suffolk County District Court System, for a term ending December 31, 2012; and be it further
