

**RESOLUTION NO. 1137 -2012, EXTENDING AUTHORIZATION  
FOR IMPROVEMENTS TO SUFFOLK AVENUE (CR 100)**

**WHEREAS**, Resolution No. 935-2006 authorized improvements to lighting and paving on CR 100, Suffolk Avenue, Town of Islip and appropriated two hundred thousand dollars (\$200,000) for this purpose; and

**WHEREAS**, Resolution No. 793-2008 authorized the County Executive to enter into an intermunicipal agreement to allow the Town of Islip to assume responsibility for the project's planning, administration and construction and to authorize the transfer of funds to the Town of Islip; and

**WHEREAS**, the Town of Islip has completed work on this project but funding has never been transferred to the Town; now, therefore be it

**1st RESOLVED**, that the duration of the project established in Resolution No. 935-2006, Capital Project 5185.310/5185.510, is hereby extended to December 31, 2013; and be it further

**2nd RESOLVED**, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
