**RESOLUTION NO. 1090-2012, SETTING DATE FOR SPECIAL  
ELECTION TO FILL VACANCY IN THE 1st LEGISLATIVE  
DISTRICT**

**WHEREAS**, Legislator Romaine has tendered his resignation from the Suffolk County Legislature effective November 26, 2012; and

**WHEREAS**, as a result of said resignation, a vacancy has occurred in the Office of County Legislator for the 1st Legislative District of the Suffolk County Legislature; now, therefore be it

**1<sup>st</sup>** **RESOLVED**, that, pursuant to Section 2-6 of the SUFFOLK COUNTY CHARTER, the Suffolk County Legislature hereby declares that a Special Election shall be held on the 15th day of January 2013, in accordance with all pertinent NEW YORK ELECTION LAW requirements, for the purpose of filling the vacancy in the 1st Legislative District, as currently constituted under Section 2-3 of the SUFFOLK COUNTY CHARTER, for the balance of the unexpired term; and be it further

**2<sup>nd</sup>** **RESOLVED**, that the Special Election shall be held for the 1st Legislative District as described and defined for the term currently to be filled, as currently constituted under Section 2-3 of the SUFFOLK COUNTY CHARTER; and be it further

**3<sup>rd</sup>** **RESOLVED**, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21), and/or (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
