

RESOLUTION NO. 1208 -2012, ACCEPTING AND APPROPRIATING FEDERAL FUNDING IN THE AMOUNT OF \$60,000 FROM THE UNITED STATES DEPARTMENT OF THE TREASURY, INTERNAL REVENUE SERVICE, FOR THE SUFFOLK COUNTY POLICE DEPARTMENT'S PARTICIPATION IN THE IRS STEPP (SUFFOLK-TREASURY ENHANCED PROSECUTION PROGRAM) WITH 81.77% SUPPORT

WHEREAS, the United States Department of the Treasury, Internal Revenue Service, has made \$60,000 in Federal funding available to Suffolk County for participation of the Suffolk County Police Department in the IRS STEPP (Suffolk-Treasury Enhanced Prosecution Program); and

WHEREAS, the operational period of the project is from October 1, 2012 through September 30, 2013; and

WHEREAS, said reimbursement funds have not been included in the 2012 Suffolk County Operating Budget; now, therefore be it

1st RESOLVED, that the County Comptroller and County Treasurer be and they hereby are authorized to accept and appropriate said grant funds as follows:


