

**RESOLUTION NO. 922 -2013, AMENDING THE 2013 ADOPTED OPERATING BUDGET TO ACCEPT AND APPROPRIATE ADDITIONAL 100% STATE AID FROM THE NEW YORK STATE OFFICE OF ALCOHOLISM AND SUBSTANCE ABUSE SERVICES (NYS OASAS) TO RIVERHEAD COMMUNITY AWARENESS AND THE PEDERSON-KRAG CENTER, INC.**

**WHEREAS**, the New York State Office of Alcoholism and Substance Abuse Services (NYS OASAS) August 26, 2013 State Aid Funding Authorization has allocated additional State Aid of \$15,192 in base funding to Riverhead Community Awareness for utility costs; and

**WHEREAS**, the NYS OASAS September 3, 2013 State Aid Funding Authorization has allocated one-time only State Aid of \$26,800 to Pederson-Krag Center, Inc. for the purchase of electronic health records hardware; and

**WHEREAS**, these additional 100% State Aid funds are not included in the 2013 Adopted Operating Budget; now, therefore be it

**1<sup>st</sup> RESOLVED**, that the County Comptroller and the County Treasurer be and hereby are authorized to accept and appropriate \$41,992 in additional State Aid as follows:
