

**RESOLUTION NO. 929 -2013, ACCEPTING AND APPROPRIATING A GRANT FROM THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY (DHS) IN THE AMOUNT OF \$25,000 FOR FY2013 PORT SECURITY GRANT PROGRAM (PSGP) TO BE ADMINISTERED BY THE SUFFOLK COUNTY SHERIFF'S OFFICE, A MEMBER OF THE EAST END MARINE TASK FORCE AND TO EXECUTE GRANT RELATED AGREEMENTS IN SUFFOLK COUNTY WITH 100% SUPPORT**

**WHEREAS**, the Suffolk County Sheriff has applied for Homeland Security funding through the 2013 Port Security Grant Program; and

**WHEREAS**, the United States Department of Homeland Security has awarded the Suffolk County Sheriff's Office \$25,000 in funds under the FY2013 PSGP to be administered by the Suffolk County Sheriff's Office; and

**WHEREAS**, the PSGP will provide funds to support training and sustainment of equipment associated with preparedness and prevention activities for terrorist events using weapons of mass destruction involving chemical, biological, radiological, nuclear materials; and

**WHEREAS**, the PSGP funds are intended to enhance maritime domain awareness, risk management capabilities to prevent, detect, respond to and recover from terrorist attacks involving Chemical, Biological, Radiological, Nuclear (CBRN); and

**WHEREAS**, this grant is for a twenty-four (24) month period in which the County will receive 100% grant funding in the amount of \$25,000; and

**WHEREAS**, the FY2013 PSGP is slated to operate for the period beginning September 1, 2013; and,

**WHEREAS**, said funds have not been included in the 2013 Operating Budget; now, therefore be it

**1<sup>st</sup> RESOLVED**, that the County Executive and Sheriff are authorized to execute any Agreement with Department of Homeland Security, as necessary, to secure said grant funds; and be it further

**2<sup>nd</sup> RESOLVED**, that the County Comptroller and the County Treasurer be and they hereby are authorized to accept and appropriate said unbudgeted grant funds in the amount of \$25,000 as follows:
