

**RESOLUTION NO. 88 -2014, AMENDING THE 2014  
OPERATING BUDGET TO PROVIDE FUNDING FOR  
LOAVES AND FISHES OF THE UNITED METHODIST CHURCH  
OF LAKE RONKONKOMA**

**WHEREAS**, the 2014 Operating Budget, when adopted, included funding for The Gather INN; and

**WHEREAS**, the United Methodist Church of Lake Ronkonkoma assumed ownership and responsibility of the soup kitchen, formerly known as The Gather INN, with the current name of the non-profit organization feeding 30 to 50 guests per night on Tuesdays and Thursdays being Loaves and Fishes of the UMCLR (United Methodist Church of Lake Ronkonkoma); and

**WHEREAS**, it is the desire of the Suffolk County Legislature to transfer the designated funding from the soup kitchen formerly known as The Gather INN to Loaves and Fishes of the UMCLR, which is the soup kitchen's current name; and

**WHEREAS**, Section 4-31 (G) of the Suffolk County Charter now allows amendment of the County Operating Budget by County Legislators four times during the fiscal year as long as the amendment reduces, lowers, terminates or cancels appropriations; abolishes positions of employment; terminates contract agencies; terminates or reduces the size of County programs or departments, or makes transfers of appropriations that are offset by reductions in other programs; now, therefore be it

**1<sup>st</sup> RESOLVED**, that the 2014 County Operating Budget is hereby amended as follows and that the County Comptroller and the County Treasurer be and hereby are authorized to transfer the following funds and authorizations:
