

**RESOLUTION NO. 802 -2014, AMENDING THE 2014  
OPERATING BUDGET TO PROVIDE FUNDING FOR THE POST  
MORROW FOUNDATION**

**WHEREAS**, the mission of the Post Morrow Foundation is to preserve and conserve the rural, cultural and historical character of the hamlet of Brookhaven and surrounding areas in Suffolk County; and

**WHEREAS**, the Post Morrow Foundation wishes to memorialize the veterans of the Revolutionary War, Civil War, Spanish American War, and the War of 1812, and to honor members of the community who were killed in action during these wars; and

**WHEREAS**, the memorial will be sited with existing memorials for more recent wars, at the location where Memorial Day ceremonies are traditionally held; and

**WHEREAS**, it is the desire of the Suffolk County Legislature to provide funding to support the Post Morrow Foundation in this effort; and

**WHEREAS**, the Pattersquash Creek Civic Assoc. will be unable to utilize the funding it was allocated in 2014; and

**WHEREAS**, the Suffolk County Legislature wishes to amend the 2014 Operating Budget to transfer funds between these agencies; and

**WHEREAS**, Section 4-31 (G) of the Suffolk County Charter now allows amendment of the County Operating Budget by County Legislators four times during the fiscal year as long as the amendment reduces, lowers, terminates or cancels appropriations; abolishes positions of employment; terminates contract agencies; terminates or reduces the size of County programs or departments, or makes transfers of appropriations that are offset by reductions in other programs; now, therefore be it

**1<sup>st</sup> RESOLVED**, that the 2014 County Operating Budget is hereby amended as follows and that the County Comptroller and the County Treasurer be and hereby are authorized to transfer the following funds and authorizations:
