**RESOLUTION NO. 1015 -2014, AUTHORIZING THE ACQUISITION AND APPROVING AND ACCEPTING THE CONVEYANCE OF A PORTION OF CERTAIN PARCELS OF REAL PROPERTY HAVING A SUFFOLK COUNTY TAX MAP IDENTIFICATION NUMBER OF DISTRICT 0500 SECTION 071.00 BLOCK 01.00 LOT 012.003 AND DISTRICT 0500 SECTION 071.00 BLOCK 01.00 LOT 012.004 FOR THE RECONSTRUCTION OF C.R. 7, WICKS ROAD, FROM C.R. 13, CROOKED HILL ROAD TO BLUE JAY DRIVE,, TOWN OF ISLIP, SUFFOLK COUNTY, NEW YORK PURSUANT TO NEW YORK STATE EDUCATION LAW SECTIONS 6304(4) AND (5) AND NEW YORK STATE COUNTY LAW SECTION 215 (3) (CP 5539)**

**WHEREAS**, two (2) parcels of real property presently owned by the Suffolk County Community College of Suffolk County, New York, and having Suffolk County Tax Map Identification Numbers of District 0500 Section 071.00 Block 01.00 Lot 012.003 and District 0500 Section 071.00 Block 01.00 Lot 012.004, are situated within the geographical boundaries of the Town of Islip, Suffolk County, New York; and

**WHEREAS**, the County of Suffolk, New York is interested in acquiring a portion of said parcels of real property for existing highway purposes, a map and description of each such portion of said parcels being attached hereto and marked as Exhibit "A" and Exhibit "B", respectively and

**WHEREAS**, the Board of Trustees of the Suffolk County Community College of Suffolk County, New York, by Resolution No. 2008.49, dated August 21, 2008, has already authorized the conveyance of said parcel(s) to the County of Suffolk, a copy of said resolution being attached hereto and marked as Exhibit "C"; and

**WHEREAS**, the conveyance and acquisition of said parcel is made pursuant to New York State Education law §§6304(4) and (5) and New York State County Law §215(3), and as such is an intergovernmental transfer is a Type II action pursuant to 6 NYCRR 617.5(c)(19) and, therefore, no further SEQRA review is required; now, therefore be it

**1<sup>st</sup>** **RESOLVED**, that the County of Suffolk does hereby authorize the acquisition and approve and accept the conveyance of that portion of the parcel having a Suffolk County Tax Map Identification of District 0500 Section 071.00 Block 01.00 Lot 012.003 and District 0500 Section 071.00 Block 01.00 Lot 012.004, more particularly described in Exhibits "A" and "B", respectively, pursuant to New York State County Law §215(3) for a consideration not to exceed Ten and 00/100 (\$10.00) Dollars (to be waived) plus pro-rata taxes at the time of closing from previously appropriated funds from CP 5539, and be it further

**2<sup>nd</sup>** **RESOLVED**, that the Commissioner of Suffolk County Department of Public Works or his designee is hereby authorized to execute all necessary documents in connection with the acquisition of the above-described parcel(s).
