

RESOLUTION NO. 895-2014, ACCEPTING AND APPROPRIATING A 100% REIMBURSED GRANT FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM AND AUTHORIZING THE COUNTY EXECUTIVE TO EXECUTE AGREEMENTS

WHEREAS, the Suffolk County Department of Economic Development and Planning has submitted an application for a Community Development Entitlement Block Grant for Federal Fiscal Year 2014 under the Housing and Community Development Acts of 1974 (P.L. 93-383), as amended; and

WHEREAS, the County has been awarded a FY 2014 entitlement Community Development Block Grant in the amount of \$2,950,181; and

WHEREAS, \$285,018 of said funds are to be used for operational costs; and

WHEREAS, these funds have been included in the 2014 Adopted Operating Budget; and

WHEREAS, the programs developed under the grant have been approved by the municipalities participating in the Suffolk County CDBG Consortium and coordination of these programs is essential to the success and continuation of the program; now, therefore be it

1st RESOLVED, that the Suffolk County Legislature hereby authorizes the County Executive or his designee to accept the Community Development Block Grant and to execute agreements with HUD and the cooperating municipalities for the expenditure of these funds; and be it further

2nd RESOLVED, that \$285,018 of these funds be used to reimburse budgeted County expenses and that the County Comptroller and the County Treasurer be, and they hereby are, authorized to accept and appropriate the following funds:
