

**RESOLUTION NO. 200 -2015, AUTHORIZING USE OF
BLYDENBURGH COUNTY PARK BY THE CURVY GIRLS
FOUNDATION, INC. FOR ITS STRAIGHT WALK WITH THE
CURVY GIRLS FUNDRAISER**

WHEREAS, Curvy Girls Foundation, Inc. is a 501(c)(3) nonprofit organization having its place of business at 81 Cygnet Drive, Smithtown, NY; and

WHEREAS, Curvy Girls Foundation, Inc. would like to use Blydenburgh County Park in Smithtown for the purpose of hosting their Straight Walk With the Curvy Girls Fundraiser to raise money for the organization; and

WHEREAS, the Straight Walk With the Curvy Girls fundraiser is scheduled to be held on Saturday, June 27, 2015 from 10:00 am to 3:00 pm with a rain date of Sunday, June 28, 2015 from 10:00 am to 3:00 pm; and

WHEREAS, a Certificate of Insurance naming Suffolk County as an additional insured will be provided by Curvy Girls Foundation, Inc. within 30 days of the Straight Walk With the Curvy Girls fundraiser; now, therefore be it

1st RESOLVED, that the use of Blydenburgh County Park by Curvy Girls Foundation, Inc. for the purpose of hosting a fundraiser on Saturday, June 27, 2015, or rain date of Sunday, June 28, 2015 is hereby approved pursuant to Section 215(1) of the NEW YORK STATE COUNTY LAW, subject to the receipt of a Certificate of Insurance and the accompanying declaration page by the County of Suffolk from Curvy Girls Foundation, Inc., and the payment of the Three Hundred Dollars (\$300.00) event fee, and subject to such additional terms and conditions as may be required by the Risk Management and Benefits Division in the County Department of Human Resources, Personnel and Civil Service; and be it further

2nd RESOLVED, that before this event shall be permitted to occur, Curvy Girls Foundation, Inc. must apply for and obtain a permit from the Commissioner of the Department of Parks, Recreation, and Conservation as required by Section 378-7(B) of the Suffolk County Code; and be it further

3rd RESOLVED, that the Commissioner of the Suffolk County Department of Parks, Recreation and Conservation is hereby authorized, empowered and directed, pursuant to Section 28-4(A) of the SUFFOLK COUNTY CHARTER, to take such measures as shall be necessary and appropriate to facilitate the hosting of the fundraiser at Blydenburgh County Park by Curvy Girls Foundation, Inc., and be it further

4th RESOLVED, that Curvy Girls Foundation, Inc. shall also provide an entertainment promoter certificate to Suffolk County if it wishes to allow vendors at the event to sell tangible personal property other than food or drink and require these vendors to display such certificate in order to comply with the provisions of the NEW YORK TAX LAW; and be it further

5th RESOLVED, that this Legislature, being the lead agency under the State Environmental Quality Review Act ("SEQRA"), New York Environmental Conservation Law,

Article 8, hereby finds and determines that this resolution constitutes a Type II action, pursuant to Volume 6 of New York Code of Rules and Regulations ("NYCRR") §617.5(c)(15), (20), and (27), in that the resolution concerns minor temporary uses of land having negligible or no permanent impact on the environment, routine, or continuing agency administration and management, not including new programs or major reordering of priorities, and adoption of a local legislative decision in connection with the same, and, since this is a Type II action, the County Legislature has no further responsibilities under SEQRA.
