RESOLUTION NO. 580 -2015, ACCEPTING AND APPROPRIATING A GRANT IN THE AMOUNT OF \$455,500 FROM THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES FOR THE 2015 MOTOR VEHICLE THEFT AND INSURANCE FRAUD (MVTIF) PROGRAM WITH 78.04% SUPPORT

WHEREAS, the New York State Division of Criminal Justice Services has made \$455,500 in State Motor Vehicle Theft and Insurance Fraud Prevention Program funds available to Suffolk County for the continuance of the Motor Vehicle Theft and Insurance Fraud enforcement program; and

WHEREAS, this program is designed to reduce the incidence of motor vehicle theft and insurance fraud within Suffolk County; and

WHEREAS, the operational period of the program will be from January 1, 2015 through December 31, 2015; and

WHEREAS, \$312,500 in permanent salary expense of the District Attorney's Office funding has been included in the 2015 Suffolk County Operating Budget; and

WHEREAS, \$312,500 in revenue of the District Attorney's Office funding for the program has been included in the 2015 Suffolk County Operating Budget; and

WHEREAS, \$143,000 in said grant funds have not been included in the 2015 Suffolk County Operating Budget; now, therefore be it

1st RESOLVED, that the County Comptroller and County Treasurer be and they hereby are authorized to accept and appropriate said grant funds as follows:
