

**RESOLUTION NO. 1063 -2015, ACCEPTING AND APPROPRIATING A GRANT AWARD FROM THE NEW YORK STATE EDUCATION DEPARTMENT, THE UNIVERSITY OF THE STATE OF NEW YORK, FOR A STATE ADULT LITERACY AND BASIC ADULT EDUCATION PROGRAM, 100% REIMBURSED BY STATE FUNDS AT SUFFOLK COUNTY COMMUNITY COLLEGE**

**WHEREAS**, Suffolk County Community College has received a grant award from the New York State Education Department, the University of the State of New York, for a State Adult Literacy and Basic Adult Education Program, in the amount of \$99,747, including indirect costs, for the period of July 1, 2015 through June 30, 2016; and

**WHEREAS**, the grant provides for a coordinated, comprehensive, standards and community-based Adult Literacy Education (ALE) program and adult secondary education/high school equivalency test preparation programs; and

**WHEREAS**, no matching funds are required as the program is 100% reimbursed by State funds; and

**WHEREAS**, the Board of Trustees of Suffolk County Community College accepted the grant award on December 3, 2015 by Resolution No. 2015; and

**WHEREAS**, the College anticipates spending the \$99,747, including indirect costs, in accordance with the terms of said grant award by June 30, 2016; now, therefore be it

**1<sup>st</sup> RESOLVED**, that said grant award, in the amount of \$99,747, including \$7,389 in indirect costs, from the New York State Education Department, the University of the State of New York, for a State Adult Literacy and Basic Adult Education Program, be accepted and appropriated for the operation of the program as follows:
