

**RESOLUTION NO. 59 -2016, AMENDING THE 2016 ADOPTED OPERATING BUDGET TO ACCEPT AND APPROPRIATE 100% ADDITIONAL STATE AID FROM THE NEW YORK STATE OFFICE OF MENTAL HEALTH TO CONCERN FOR INDEPENDENT LIVING AND OPTIONS FOR COMMUNITY LIVING INC., FOR THE PURPOSE OF DEVELOPING MOBILE RESIDENTIAL SUPPORT TEAMS**

**WHEREAS**, the New York State Office of Mental Health has issued 100% additional State Aid in the amount of \$758,740 for an expansion of community services by the development of a new program; and

**WHEREAS**, these additional funds are to be used to develop three (3) mobile residential support teams which will cover Western Suffolk, Central Suffolk and Eastern Suffolk; and

**WHEREAS**, the Department of Health Services issued a Request for Proposal (RFP) for "Mobile Residential Support Team Services" for its Division of Community Mental Hygiene Services; and

**WHEREAS**, the Purchasing Division of the Department of Public Works advertised for these services and Concern for Independent Living and Options for Community Living Inc. were the successful proposers to RFP 15036 and were both deemed to be qualified contractors; and

**WHEREAS**, through the RFP process it was deemed that Concern for Independent Living would operate the teams in Central and Eastern Suffolk and Options for Community Living Inc. would operate the team in Western Suffolk; and

**WHEREAS**, this additional 100% State Aid is not currently included in the 2016 Adopted Operating Budget; now, therefore be it

**1<sup>st</sup> RESOLVED**, that the County Comptroller and the County Treasurer be and hereby are authorized to accept and appropriate \$758,740 in additional State Aid as follows:
