

**RESOLUTION NO. 478 -2016, AUTHORIZING USE OF OLD
FIELD FARM FOR GALLERY NORTH'S WET PAINT FESTIVAL**

WHEREAS, Gallery North, a not-for-profit organization, is hosting the Wet Paint Festival, an event held annually in the Setauket area; and

WHEREAS, Gallery North would like to use the parking lot at Old Field Farm in connection with this outdoor painting event which pays tribute to late Long Island native Joseph Reboli; and

WHEREAS, Gallery North would like to use the parking lot at Old Field Farm in connection with this annual festival on Friday, July 15, 2016, Saturday, July 16, 2016 and Sunday, July 17, 2016 from 10:00 a.m. to 5:00 p.m.; and

WHEREAS, a Certificate of Insurance naming Suffolk County as an additional insured has been provided by North Gallery; and

WHEREAS, the County of Suffolk shall receive consideration in the total amount of Three Hundred Dollars and 00/100 (\$300.00), payment of which shall be guaranteed by Gallery North; now, therefore be it

1st RESOLVED, that the use of County-owned property, i.e., Old Field Farm, in consideration of the payment of Three Hundred Dollars and 00/100 (\$300.00), for the purpose of using Old Field Farm's parking lot on Friday, July 15, 2016, Saturday, July 16, 2016 and Sunday, July 17, 2016 between the hours of 10:00 a.m. and 5:00 p.m., to accommodate approximately 100 attendees over a three-day span, is hereby approved pursuant to Section 215(1) of the NEW YORK COUNTY LAW, subject to the County's receipt of a Certificate of Insurance naming the County of Suffolk as an additional insured from Gallery North, and subject to such additional terms and conditions as may be required by the Risk Management and Benefits Division in the County Department of Law; and be it further

2nd RESOLVED, that the Commissioner of the County Department of Parks, Recreation and Conservation is hereby authorized, empowered and directed, pursuant to Section 28-4(A) of the SUFFOLK COUNTY CHARTER and Section 643-7 of the SUFFOLK COUNTY CODE to issue a permit to Gallery North . The Department of Parks, Recreation and Conservation and the County Department of Public Works are further authorized, empowered and directed to take such measures, either alone or in conjunction with each other, as shall be necessary and appropriate to facilitate the use of Old Field Farm's parking lot; and be it further

3rd RESOLVED, that this Legislature, being the lead agency under the State Environmental Quality Review Act ("SEQRA"), New York Environmental Conservation Law, Article 8, hereby finds and determines that this resolution constitutes a Type II action, pursuant to Volume 6 of New York Code of Rules and Regulations ("NYCRR") §617.5(c)(15), (20), and (27), in that the resolution concerns minor temporary uses of land having negligible or no permanent impact on the environment, routine, or continuing agency administration and management, not including new programs or major reordering of priorities, and adoption of a local legislative decision in connection with the same, and, since this is a Type II action, the County Legislature has no further responsibilities under SEQRA.
