RESOLUTION NO. 482 -2016, ACCEPTING AND APPROPRIATING A GRANT IN THE AMOUNT OF \$1,068,093 FROM THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES FOR THE GUN INVOLVED VIOLENCE ELIMINATION (GIVE) III PROGRAM WITH 90.84% SUPPORT

WHEREAS, the New York State Division of Criminal Justice Services has made \$1,068,093 in State funding available to Suffolk County to continue efforts to reduce violent crime, particularly gun-related crimes; and

WHEREAS, said grant funds are to be distributed between the Suffolk County District Attorney’s Office, the Suffolk County Police Department, the Suffolk County Crime Lab, the Suffolk County Probation Department and the Suffolk County Sheriff’s Office; and

WHEREAS, the operational period of the program will be from July 1, 2016, through June 30, 2017; and

WHEREAS, \$369,789 in permanent salary expense and \$147,904 in fringe benefits of the District Attorney’s Office funding for the program has been included in the 2016 Suffolk County Operating Budget and in the 2017 Operating Budget Request; and

WHEREAS, \$517,693 in revenue of the District Attorney’s Office funding for the program has been included in the 2016 Suffolk County Operating Budget and in the 2017 Operating Budget Request, and

WHEREAS, \$550,400 in said grant funds have not been included in the 2016 Suffolk County Operating Budget, now, therefore be it

1st RESOLVED, that the County Comptroller and County Treasurer be and they hereby are authorized to accept and appropriate said grant funds as follows:

4th **RESOLVED**, that the County Executive be and hereby is authorized to execute the grant agreement between Suffolk County and the New York State Division of Criminal Justice Services.
