

**RESOLUTION NO. 533 -2016, ACCEPTING AND APPROPRIATING FEDERAL PASS-THROUGH GRANT FUNDS FROM THE NYS DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES (DHSES) IN THE AMOUNT OF \$50,000 FOR "OPERATION SHIELD 2016" UNDER STATE HOMELAND SECURITY PROGRAM (SHSP FY2015) TO BE ADMINISTERED BY THE SUFFOLK COUNTY SHERIFF'S OFFICE IN PARTNERSHIP WITH THE SUFFOLK COUNTY POLICE DEPARTMENT, THE EAST END MARINE TASK FORCE AND VARIOUS OTHER FEDERAL, STATE AND LOCAL AGENCIES, AND TO EXECUTE GRANT RELATED AGREEMENTS WITH 100% SUPPORT**

**WHEREAS**, the New York State Division of Homeland Security and Emergency Services has awarded the Suffolk County Sheriff's Office \$50,000 in funds under the SHSP FY2015 grant program to be administered by the Suffolk County Sheriff's Office; and

**WHEREAS**, the SHSP FY2015 will provide funds for high visibility maritime enforcement for prevention and response to terrorist attacks, and to minimize danger of and support recovery from terrorist attacks; and

**WHEREAS**, this grant provides funding for a minimum of one operation for the 2016 July 4<sup>th</sup> period, the Sheriff's Office will receive 100% grant funding in the amount of \$50,000; and

**WHEREAS**, the SHSP FY2015 funding is slated for operation for the period beginning 05/01/2016 to 12/31/2017; and

**WHEREAS**, said funds have not been included in the 2016 Operating Budget; now, therefore be it

**1<sup>st</sup> RESOLVED**, that the County Comptroller be and is hereby authorized to accept and appropriate said unbudgeted grant funds in the amount of \$50,000 as follows:
