

RESOLUTION NO. 620 -2016, ACCEPTING AND APPROPRIATING 100% FEDERAL GRANT FUNDS FROM THE DEPARTMENT OF HEALTH AND HUMAN SERVICES FOOD AND DRUG ADMINISTRATION IN THE AMOUNT OF \$70,000 FOR THE ADVANCING SUFFOLK COUNTY'S CONFORMANCE WITH THE VOLUNTARY NATIONAL RETAIL FOOD REGULATORY PROGRAM STANDARDS (VNRFRPS) ADMINISTERED BY THE SUFFOLK COUNTY DEPARTMENT OF HEALTH SERVICES, DIVISION OF PUBLIC HEALTH AND TO EXECUTE GRANT RELATED AGREEMENTS

WHEREAS, the Department of Health and Human Services Food and Drug Administration has awarded Suffolk County Federal funds under the Advancing Suffolk County's Conformance with the VNRFRPS grant to be implemented by the Suffolk County Department of Health Services, Division of Public Health; and

WHEREAS, the VNRFRPS will provide funds to the Department of Health Services to support an increase in active managerial control and decrease in the occurrence of risk factors that contribute to food borne illness; and

WHEREAS, this grant has a start date of 7/1/2016 and ends on 6/30/2017 in which the County will receive 100% grant funding in the amount of \$70,000 for the VNRFRPS; and

WHEREAS, as said funds have not been included in the 2016 Operating Budget; now, therefore be it

1st RESOLVED, the County Comptroller be and they hereby are authorized to accept \$70,000 and appropriate said grant funds as follows:
